The role's principal accountabilities will be in:

Sourcing development opportunities:

- Work alongside the Director to deliver regional strategy which maximises TPR.
- Adopt a dynamic approach to the delivery and sourcing of land opportunities, including change of use, partnership and land promotion opportunities.
- Identify opportunities for new maximum value, market leading mixed-use developments in target locations, leading initial design, due diligence and presentation to BU Leadership.

- Work in collaboration with Asset Management, Technical Development, Group Investment, and Partnership Development teams to prepare compelling business cases in support of acquisitions.
- Manage new acquisitions from inception through to completion and handover to BU Asset Management/ Project Delivery teams, leading on communications and project updates.
- Establish and maintain market presence and a strong network with all external stakeholders, including agencies, consultants, customers, and stakeholder networks.
- Coordinate new business process including presentations to BU Leadership, managing introductions, maintenance of land and investment transactions database and library.

Investment

- Identify and execute acquisitions and disposals of land and property as part of the capital recycling programme, in line with Group objectives.
- Ensure deals are delivered diligently and with maximum commerciality.
- Manage and coordinate bi-annual valuations for the Thames Valley business unit.
- Coordinate, evaluate and disseminate MSCI portfolio benchmarking.
- Manage and coordinate the business unit annual forecasting and budget process.
- Support Asset Management team with strategic asset management initiatives across the portfolio, including implementing an analytics-based approach to portfolio decision making.
- Regularly collaborate with Group Investment and other BU Investment Directors, including on shared initiatives such as portfolio transactions and group research and benchmarking projects.
- Lead on new research initiatives for Thames Valley, managing external consultants.
